

# Mini-Course: Intellectual Property and Competition Law in the context of Covid-19 Pandemic



Short summary of proposal: Mini-course organized by the South Centre and the Court of Appeal for Specialized Cases, Thailand to: (i) examine with Thai judges, prosecutors, competition authority officials, administrative court officials, and other public servants the utilization of TRIPS flexibilities (including competition law) in the context of the COVID 19 pandemic; (ii) discuss issues of relevance to Thailand and other developing countries at the intersection between intellectual property and competition law; (iii) identify issues for the in-person course planned to be held in Bangkok in May 2022.
